Cost Items

The following is a list of start-up costs associated with formulating a contract grazing business. Depending on your starting point, not all items may relate to you. These startup items are based on a starting herd of 250 sheep and/or goats and employing one H-2A visa employee. To view the cost of all items please view our Start-Up Cost Table on page 3.

Start-Up Cost Items:

- 1. Livestock
 - o Goats and or sheep
- 2. Electric Fencing
 - For a herd of 250 goats or sheep you will need at least 15 electric fencing nets to start. Suggested fencing includes:
 - Premier 1 Supply: Pos/Neg ElectroStop 10/42/12 (164'x42" white/black roll) single spike. Item #204000
- 3. Solar Charger for Electric Fencing
 - Gallagher S400 Solar Fence Energizer
 - Combination System
 - Speedrite Energizer:
 - 12v battery
 - Grounding rod
 - Solar panel with regulator
- 4. Water Trough
- 5. Water Trailer
 - o Multiquip WT5C with reel-\$9,800 https://www.multiquip.com/multiquip/wt5c.htm
 - Wylie 500- \$10,800
 - Wylie 800 \$14,500
 - WT5C
- 6. Medications/ Vaccinations
- 7. Truck
 - New Base model 3500 Truck with 4-Wheel Drive: Minimum \$60,000 without tax and licensing
- 8. Stock Trailer
 - \circ $\,$ For a new stock trailer, you can expect to spend \$50,000.00 $\,$
 - Used stock trailers in good working condition will cost around \$30,000

 - Used travel trailers in good working condition are often \$7,000-\$10,000 with new travel trailers being upwards of \$15,000.

Monthly Expense Items

- 1. Employees
 - H-2A employees
 - In 2024 employers that have 25 or fewer employees are required to pay H-2A visa employees \$4,024.36 plus a monthly food allowance of \$420.00 per month.
 - Telephone and internet

Miscellaneous Expense items to consider

- 1. Winter Feed
 - a. On average you can expect to need to feed your animals for three months out of the year during the off season. To feed 250 animals you can expect to spend between \$20,000-\$25,000.00 in feed depending on where you are located and what is available that year.
- 2. Maintenance on equipment
- 3. Fuel and propane
- 4. Office Supplies and billing systems fees

If you plan to start with a smaller or larger herd, these example costs will differ from yours. Additionally, these costs are average prices for 2023 and do not include taxes.
